- The Futurity is open to all horses/riders/owners, no matter what nationality.
- Class entry authorization must be verified according to NRHA rulebook.
- Entry conditions: Riders and owners must have a valid ARHA and NRHA membership. The horse needs a Competition License.
- Max. 3 horses per rider, per class. Two Go's per class.
- There is no contractual relationship between the promoter on the one hand and the visitors, horse owners and participants on the other hand. Liability for theft and injury of persons and animals is excluded.
- Each horse must be liability insured and free of an epidemic and must come out from a stable which is epidemical free. The horse must be as well vaccinated against influenza. The certificate of vaccination must be carried with and has to be shown at the show office.
- Video Charge (obligatory) € 7,- & € 5,-/start/CD included.
- Equipment according to NRHA Handbook of Rules and Regulations 2008.
